1. **Length of rental:** 1 week starting from the date of delivery.

 2. **Price:** \$225.00
 3. **Restrictions on Materials Placed in Dumpster:** I represent and warrant that the materials placed in the dumpster shall not include any of the items in Schedule A to this form - Unacceptable Items in Residential Dumpsters.
 4. **Hold Harmless and Indemnification:** In consideration of the Borough of Hampton renting a dumpster to me, I hereby agree to hold the Borough of Hampton, its officers, agents, servants, employees, and their successors, harmless from any and all claims, demands, causes of action, costs, expenses, liability, loss, damage or injury, in law or equity, to property or persons, including wrongful death, in any manner arising out of or incident to the location, condition or use of said dumpster. This obligation includes without limitation the payment of all consequential damages and attorneys' fees and other related costs and expenses. I further agree to indemnify the Borough of Hampton, its officers, agents, servants, employees, and their successors, against any loss as a result of claims of persons or entities arising in any way from location, condition or use of said dumpster. Title to and liability for any waste excluded above shall remain with me and I expressly agree to defend, indemnify and hold harmless the Borough from and against all damages, penalties, fines and liabilities resulting from or arising out of such waste excluded above.

Batteries: lead acid, automobile and household

Bio-hazard and medical waste and red bag waste

Brush

Chemicals, including pesticides, pool chemicals, fertilizers

Concrete, bricks and blocks

Electronics of any kind

Explosives

Fluorescent light bulbs, ballasts and batteries

Grass clippings

Sofas or couches

Lawn and garden chemicals and other household liquids and chemicals

Leaves, bagged

Mercury containing products or appliances

Paints and solvents

PCB's

Petroleum products

Propane cylinders or other pressurized tanks, empty or full

Radioactive and nuclear waste

Recyclable materials

Refrigeration units including dehumidifiers, air conditioners, freezers, etc.

Rock, soils, and dirt
