The Mayor and Borough Council asked Ms. Leidner to review the applications that were received during the previous search for crossing guards.

Cm. Drummond welcomed Mr. Brower back and noted that he wanted to thank Deputy Director Matt Schafer for stepping in and taking care of everything during Mr. Brower's absence.

Cm. Drummond inquired about the status of the Lumberyard. And asked that this item be placed on future agendas as Old Business so that the Borough Council can be sure that the project is moving forward.

Mr. Brower noted that Top Line Construction will begin the Main Street Improvement Project around August 25.

Cm. Wotanowski reported that William Fleck is looking at a different type of flag pole for his Eagle Project and has been in touch with the proper people to move his project forward.

A SHARED SERVICES AGREEMENT FOR
"POLICE SUPERVISION OF CROSSING GUARD SERVICES"
BETWEEN THE TOWN OF CLINTON AND THE BOROUGH OF HAMPTON
TO PROVIDE MANAGED CROSSING GUARD SERVICES

WHEREAS, the Borough of Hampton and the Town of Clinton wish to enter into a Shared Services Agreement for Police Supervision of Crossing Guard Services ("Agreement") effective August 11, 2020, whereby the Town of Clinton will provide managed Crossing Guard Services to the Borough of Hampton; and pursuant to and permitted by the Uniform Shared Services and Consolidation Act., N.J.S.A. 40A:65A-1, et seq.; and

WHEREAS, the Shared Services Agreement (attached hereto) will provide the management, training and supervision of School Crossing Guard services as outlined in the Agreement; and

WHEREAS, the Shared Services Agreement shall be for a period of three (3) years and may be terminated by either party by at least one year's written notice of in advance of the date of the termination; and

WHEREAS, the Borough of Hampton shall pay to the Town of Clinton a per annum service fee of \$7,500, which fee includes the cost of administrative supplies, equipment and vehicle usage; and

WHEREAS, the Borough of Hampton shall pay all fees outlined in the Agreement, including a per annum service fee of \$7,500 covering the cost of administrative supplies, equipment and vehicle usage; equipment cost; annual Crossing Guard costs; and initial costs.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Hampton, Hunterdon County, New Jersey, as follows:

1. The Mayor and Clerk are hereby authorized to execute the attached Shared Services Agreement for Police Supervision of Crossing Guard Services between the Borough of Hampton and the Town of Clinton;

AND BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
