REGULAR MEETING MINUTES

October 26, 2020

This meeting was held in person and was open to the Public.

Mayor Shaner called the Regular Meeting of the Hampton Borough Council to order at 7:30p.m. Mayor. Shaner gave the Open Public Meetings Act Statement. This meeting was held in compliance with the Open Public Meetings Act. The Annual Notice was adopted on January 6, 2020 and was published in the Hunterdon Democrat on January 09, 2020. The Annual Notice has been posted on the public bulletin board and has been filed in the Office of the Municipal Clerk.

Mayor Shaner asked all to rise for the flag salute.

Comments and Questions from the Public:

Pam Bailey: Spoke as Alternate delegate to the Musconetcong River Management Council. Ms. Bailey noted that the U.S. Secretary of the Interior David L. Bernhardt designated the Musconetcong River and the Musconetcong Watershed National Water Trail to the National Trails System earlier this month. The watershed goes from Lake Hopatcong all the way to Delaware. Hampton is on the official map that can be found on nationaltrails.org.

Fire Chief Rick Allen reported that the Fire Company Annual Halloween Parade is still on for Saturday, October 31, 2020 at 1:00pm.

Communications:

Letter from Hunterdon County Agriculture Development Board requesting to be paced on the agenda to discuss Grochowicz Family application for Farmland Preservation – Bob Hornsby, CADB Administrator will be in attendance.

Bob Hornby of the Hunterdon County Agriculture Development Board explained the history behind the Grochowicz family application to the board for Farmland Preservation of their property, portion located in the Borough of Hampton known as Block 11, Lots 1,2 & 2.02. The remaining portions of the property are located in Glen Gardner and Bethlehem Township.

Minutes: October 26, 2020

Mr. Hornby presented an option to Hampton Borough for funding this farmland preservation by using a County Open Space Grant to cover the Municipal portion of the County Planning Incentive Grant. There funds available in the Borough's County Open Space funding account. The amount from that fund needed to satisfy the local contribution would be \$49,337.50. There would be no out of pocket expense to the Borough as well as no long term costs associated with this Farmland Preservation or Grant Funding.

Property owner Thomas Grochowicz explained that the farm has been owned by his family since 1952 and the Third Generation would like to continue farming on the property.

No decision was needed this evening, Mr. Hornby will prepare a Resolution for consideration at the November 16, 2020 meeting of the Hampton Borough Council.

School Study Subcommittee – The committee had a meeting prior to this Regular Borough Council Meeting to discuss how to discuss questions that they would like answered by the Board of Education. The questions will be forwarded to Jason Kornegay, Superintendent of Hampton School.

Sale of Vacant Properties Owned by the Borough – This was discussed under New Business.

REPORTS OF COMMITTEES

Cm. Swenson: Alan Brower, Water Operator, reported that the flow meter is back for Well #5. The second well house is painted. New curb boxes and valves were put into place during the Main Street paving project as needed.

Minutes: October 26, 2020

Cm. Drummond asked Patrick Brennan, Borough Engineer to give an update on the Main Street paving progress. Mr. Brennan reported that milling and paving is done and it is anticipated that striping will be done tomorrow. This process does not take long to dry so road closures and detours should be at a minimum.

Discussion were held regarding the replacement of the guard rail at Main Street and Valley Road.

Cm. Tampier reported that with the newly paved street comes speeding. Mr. Tampier will reach out to the State Police to see about extra police presence to curb speeders...

Cm. Rega & Cm. Wotanowski had no reports at this time.

Mayor Shaner noted that a resident had their car towed because it was parked on Main Street during the construction. The resident reached out to Mayor Shaner because he felt that there was not enough signage or warning to see if there was any way to get the towing fees reimbursed to him.

Mr. Brower, DPW Director and Municipal Clerk Leidner explained that fliers were placed on car windows, there were notifications on the Borough Website and on Facebook. Also, the day of the towing the contractor went door to door trying to find out who owned the vehicle.

It was the consensus of the members of the Borough Council that the towing fees not be reimbursed.

New Business:

The Introduction of this Ordinance was tabled to the next meeting to be held on November 16, 2020 as more information is needed on the properties. A PERC test has been scheduled for the property on MacKenzie Road. There is also a water line that goes through the property on 202 Route 31 North.
