BOROUGH OF HAMPTON

REGULAR MEETING June 14, 2021

Mayor Shaner called the Regular Meeting of the Hampton Borough Council to order at 7:30p.m. Mayor Shaner gave the Open Public Meetings Act Statement. The notice of this meeting was advertised in the Hunterdon Democrat on January 14, 2021. The notice was posted on the public bulletin board and is on file in the Office of the Municipal Clerk.

The following people were also present: Kathy Olsen, CFO, Matt Lyons and Alan Brower, DPW Director.

Motion by Cm. Wotanowski, second by Cm. Rega to approve the Minutes of the May 24, 2021 Regular Meeting and May 24, 2021 Executive Session.

Voice Vote. All ayes, motion carried.

Comments and Questions from the Public:

Pam Bailey, Musconetcong River Council – explained that the Musconetcong River is named on the National Registry as a Naturally Scenic River and the Musconetcong Watershed Association is requesting permission to place a sign near Hampton Borough Park noting this recognition. Ms. Bailey explained that the Musconetcong Watershed Association will pay for and install the sign, however they are requesting permission to do so.

Motion by Cm Wotanowski, second by Cm. Celentano to authorize the Musconetcong Watershed Association to install a sign near the Hampton Borough Park under the guidance of the Director of Public Works Alan Brower.

Voice Vote. All ayes, motion carried.

Tom Carpenter, 196 Route 31 N – noted that he submitted a letter of concern addressed to the Mayor and Borough Council regarding a sunken manhole on Route 31 in front of his residence. Mr. Carpenter wanted to go on record because this manhole has caused tire blowouts and accidents. When the cars hit the manhole it causes drivers to lose control and is very dangerous.

It was explained to Mr. Carpenter that this issue has been reported to the NJDOT by both the Borough Clerk and DPW Director. Mr. Brower noted that the NJDOT was out at the site today measuring the manhole.

Mr. Carpenter also noted the loud noise created by Jake brakes and recommends an Ordinance against the use of this type of brakes. He also recommends the removal of a tree at the end of Bowlby Street due to sight distance concerns.

Vicki Molloy from Concord Energy was in attendance at the meeting to explain this cost saving program to the Mayor and Borough Council members. The program is for municipalities only, not for residents.

The timeline for this program is-

Invitation to participate by end of June. Bidding is done by July 15, August 17 would be the acceptance of the award of contract by Concord Energy and the savings program will begin with the October meter read. Electricity contracts can only be implemented for 2 years at a time. The Borough can choose to opt out at any time. Many municipalities in Hunterdon County are a part of this program.

Motion by Cm. Swenson, second by Cm. Rega to have Hampton Borough to join in the aggregation of Electrical Supply through Concord Energy and to authorize the Mayor and Borough Clerk to execute the agreement.

Ashley DeGrandis from Engineering and Land Planning Associates was in attendance to explain the Administrative Consent Order as it pertains to the Lumberyard Property

Ms. DeGrandis explained where the Borough stands currently in the remediation process along with the steps moving forward. The Administrative consent Order that needs to be executed by the Mayor includes:

Implementation of Schedule

Public Participation Plan

Payment of Outstanding Fees

Ms. DeGrandis explained that once this document has been signed a NJDEP Enforcement Officer will be assigned to the site.

There was concern regarding the NJDEP Remediation Fees of \$12,310 that are due to the State. Borough Attorney Matt Lyons explained that the fees go back many years and the state has not waived these fees over the years.

Motion by Cm. Swenson, second by Cm. Drummond to authorize the Mayor and Borough Clerk to execute the Administrative Consent Order, contingent on receiving the Certification and availability of Funds from the Chief Financial Officer.

WHEREAS, the Morris County Cooperative Pricing Council ("MCCPC") was created in 1974 to conduct a voluntary cooperative pricing system with municipalities, boards of education, and other public bodies located in the County of Morris and adjoining counties; and

WHEREAS, the purpose of the MCCPC is to provide substantial savings on various goods and services to its members through the cooperative public bidding process; and

WHEREAS, the Borough of Hampton desires to enter into an Agreement with the MCCPC, which is administered by Randolph Township as Lead Agency, to renew its membership in the MCCPC for the period October 1, 2021 through September 30, 2026.

BE IT RESOLVED, by the Borough of Hampton, County of Hunterdon, State of New Jersey as follows:

1. Mayor and Borough Council of the Borough of Hampton hereby authorizes the execution of an Agreement with the Morris County Cooperative Pricing Council by the Township of Randolph as Lead Agency dated October 1, 2021, pursuant to N.J.S.A. 40A:11-11(5). Said Agreement is for renewal of membership in the MCCPC for a five (5) year period from October 1, 2021, through September 30, 2026.

- 2. The Hampton Borough Clerk is hereby directed to submit a copy of this adopted Resolution, along with an executed Agreement, to Randolph Township as Lead Agency of the MCCPC.
- 3. This Resolution shall take effect immediately upon final passage according to law.
- 4. All appropriate Borough of Hampton officials are authorized and directed to perform all required acts to affect the purpose of this Resolution.
