WHEREAS, the <u>Borough</u> Council further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the <u>Borough</u> Council has applied for funding to the Governor's Council on Alcoholism and Drug Abuse through the County of <u>Hunterdon</u>;

NOW, THEREFORE, BE IT RESOLVED by the <u>Borough</u> of <u>Hampton</u>, County of <u>Hunterdon</u>, State of New Jersey hereby recognizes the following:

RESOLUTION NO. 59-2021 - GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT RESOLUTION NO. 59-2021

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2020 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and,

WHEREAS, R.S. 52:27BB-34 authorizes the local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations, and,

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations", as evidenced by the group affidavit form of the governing body attached hereto; and,

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than fortyfive days after the receipt of the annual audit, pursuant to N.J.A.C 5:30-6.5, and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S, 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

NOW, THEREFORE BE IT RESOLVED, that the Borough Council of the Borough of Hampton, hereby states that it has complied with N.J.A.C. 5:30-6.5, and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

WHEREAS, the Borough of Hampton, Hunterdon County, New Jersey, is in need of a Tax Assessor due to retirement; and

WHEREAS the Hampton Borough Personnel Committee conducted the appropriate interviews; and

WHEREAS, the Hampton Borough Personnel Committee recommends the appointment of Jeffrey Ward to the position; and

WHEREAS, N.J.S.A. 40A:9-148 states, "Every municipal Tax Assessor...shall hold his office for a term of 4 years from the first day of July, next following their appointment therefore, the term of appointment for Jeffrey Ward will be effective from July 1, 2021 through June 30, 2025.

NOW, THEREFORE BE IT RESOLVED by the Borough Council of the Borough of Hampton, Hunterdon County, New Jersey, hereby appoints Jeffrey Ward as Tax Assessor at a salary of \$10,071.45 for a 4 year term effective from July 1, 2021 and ending on June 30, 2025.

WHEREAS, N.J.S.A.11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, the County of Passaic, hereinafter referred to as the "Lead Agency " has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services; and

WHEREAS, the Borough of Hampton, Hunterdon County is desirous of participating in said Passaic County Cooperative Pricing System ID# 38PCCP which will give the Borough another option to State Contracts.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF HAMPTON, HUNTERDON COUNTY, NEW JERSEY, as follows:

1. Pursuant to the provisions of N.J.S.A. 40A:11-11(5), the County's Purchasing Agent is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

2. The Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

3. This resolution shall take effect immediately upon passage.
