#### **Comments and Questions from the Public:**

#### **Communications:**

Memo received from Tax Assessor re: Letter from the Division of Taxation re: equalized valuation for 2023 increased by 10% or more from 2022.

Tax Assessor Jeffrey Ward was in attendance to explain what the letter means. Mr. Ward noted that 267 municipalities received a similar letter. This is directly related to the rapid appreciation of real estate values, low inventory and high selling prices. At this time how this will affect the Borough is unknown. The increase in equalized value will adversely affect Hampton Borough's 2024 contributions to the Regional School and County levies.

## ORDINANCE NO. 09-2023 - AN ORDINANCE TO AMEND CHAPTER 93 "ANIMALS" OF THE CODE OF THE BOROUGH OF HAMPTON

**WHEREAS,** Chapter 93 of the Code of the Borough of Hampton regulates the licensing of dogs, removal of animal feces, and inoculation of cats; and

**WHEREAS**, the provisions of Chapter 93 are based in part on *N.J.S.A.* 4:19-15.1, *et seq.* which has been amended since the last revision to Chapter 93; and

**WHEREAS**, the Mayor and Council wish to revise Chapter 93-2 "Dog Licensing Requirements," Subsection C (1) and(2) "Fees, renewals, expiration date of licenses," to provide for an increase of fees; and

**WHEREAS,** the Mayor and Council also wish to revise Chapter 93-4 "Disposition of Fees," Subsection B, to clarify payments to the State of New Jersey.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Hampton, Hunterdon County, State of New Jersey, that Chapter 93 entitled "Animals" of the Code of the Borough of Hampton is hereby amended as follows: Section 1.

§ 93-2 "Dog Licensing Requirements;" Subsection C (1) and (2) "Fees, renewals, expiration date of licenses," is amended as follows (additions indicated in boldface and italics "thus;" deletions indicated with strike-through "thus"):

- (1) The person applying for the license and registration tag shall pay the fee established in the sum of \$1 \$10.00 for the registration tag of each dog, and for each annual renewal, the fee for the license and for the registration tag shall be the same as for the original license and tag. The licenses, registration tags and renewals thereof shall expire on January 31 in each year.
- (2) In addition to the fee charged pursuant to Subsection C (1) above, any person applying for a license and registration tag shall pay:
  - (a) A fee of \$3 for any dog of reproductive age which has not had its reproductive capacity permanently altered through sterilization to be forwarded to the State Treasurer for deposit in the Animal Population Control Fund.
  - (b) An additional fee of \$0.20 to be forwarded to the State Treasurer to fund the animal sterilization pilot clinic.

## Section 2.

§ 93-4 "Disposition of Fees" Subsection B is amended as follows (additions indicated in boldface and italics "thus;" deletions indicated with strike-through "thus"):

B. The registration tag fee of \$1 for each dog shall be forwarded within 30 days after collection by the Borough Clerk or other designated official to license dogs to the State Department of Health and Senior Services, which Department shall forward the sum to the State Treasurer,

who shall place all such moneys in a special account for use only by the State Department of Health and Senior Services in administering this article and for the prevention and control of rabies throughout the state, and such account is hereby declared to be a trust fund not subject to legislative appropriation. At the end of the third fiscal year following the adoption of this article, and at the end of each fiscal year thereafter, there shall be withdrawn from this trust fund and transferred to the general funds of the state any amount then in such fund which is in excess of the total amount paid into such fund during the last two fiscal years next preceding.

- C. Pursuant to § 93-2 Subsection C (2) (a) (b), an additional \$3.20 is being forwarded to the State of New Jersey as follows:
  - (a) A fee of \$3 for any dog of reproductive age which has not had its reproductive capacity permanently altered through sterilization to be forwarded to the State Treasurer for deposit in the Animal Population Control Fund.
  - (b) An additional fee of \$0.20 to be forwarded to the State Treasurer to fund the animal sterilization pilot clinic for each dog in Section (a) above.

**Section 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed. **Section 4.** If any section, phrase or portion of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction for any reason, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof. **Section 5.** This Ordinance shall take effect upon final passage and publication according to law.

**Lumberyard** – No update.

Municipal Liens – Attorney Tara St. Angelo explained that there was a Supreme Court Ruling on a case I United States Supreme Court's decision in <u>Tyler v. Hennepin County</u>, 598 U.S. \_\_\_\_, 143 S. Ct. 1369 (2023), the New Jersey Supreme Court temporarily has suspended Office of Foreclosure recommendations of final judgment in tax sale certificate cases filed after May 25, 2023. The Court Order also has relaxed certain Court Rules governing in rem and in personam tax foreclosures. Attorney St. Angelo recommended going over the list of properties, due to the fact this the new rules will prove to be costly.

## **Reports of Committees:**

**Cm. Swenson** explained that the Department of Public Works will be down an employee due to illness and we have a part-time person that he would like to recommend authorizing him to work full time hours to fill the temporary vacancy.

Motion by Cm. Swenson, second by Cm. Wotanowski to authorize current part time DPW employee Anthony Schiraldi to work full time hours to fill the temporary vacancy of a DPW employee due to illness.

Roll call vote: Celentano, Hansen, Rega, Swenson, Tampier, Wotanowski All ayes: Motion carried.

**Cm. Swenson** also inquired about the ability for the Borough to obtain a credit card for ease purchasing and so that employees don't have to use their own for Borough purchases. Both CFO Olsen and Borough Attorney St. Angelo explained that under State law, municipalities are not allowed to have credit cards.

**Cm. Tampier** inquired as to why the Borough was fined by the State Fire Code Enforcement Officer. It was explained that this is the ongoing issue of the fire door in the hallway of Borough Hall. The Code Enforcement officer has not responded to our DPW Director regarding the inspection of the door. Approval is needed before the State Fire Code Enforcement Officer will note that the requirement for the fire door is fulfilled.

**Cm. Rega** reported that he spoke to the Animal Control Officer Robbie Lagonera regarding next year's contract. Cm. Rega noted that Mr. Lagonera was asking if the Borough was interested in entering into a shared service. Borough Attorney St. Angelo explained that this not allowed due to the fact that Mr. Lagonera is not an employee of the borough.

**Cm. Wotanowski** noted that there will be an Executive Session regarding personnel, specifically filling the Tax Collector vacancy due to retirement.

Cm, Celentano and Cw. Hansen had nothing to report.

AUTHORIZATION TO EXECUTE ALL AGREEMENTS NECESSARY FOR A SHARED SERVICES AGREEMENT FOR THE DISPOSAL OF LEAVES AT THE DEWEY AVENUE NATURAL RECYCLING CENTER IN THE BOROUGH OF HIGH BRIDGE, BETWEEN THE BOROUGH OF HAMPTON AND THE BOROUGH OF HIGH BRIDGE

WHEREAS, the Borough of Hampton and the Borough of High Bridge wish to enter into a Shared Services Agreement for the disposal of leaves collected by Hampton at the Dewey Avenue Natural Recycling Center (the "Yard") effective November 3, 2023, whereby the Borough of High Bridge will accept the disposal of Hampton's leave collection; and pursuant to and permitted by the Uniform Shared Services and Consolidation Act., N.J.S.A. 40A:65A-1, et seq.; and

**WHEREAS**, the Shared Services Agreement (attached hereto) will provide access to the Yard by the Borough of Hampton as outlined in the Agreement; and

WHEREAS, the Shared Services Agreement shall be for a period of three (3) years and may be terminated by either party by at least one year's written notice of in advance of the date of the termination; and

WHEREAS, the Borough of Hampton shall pay to the Borough of High Bridge a fee of \$16 per cubic yard up to 200 yards per year, which fee includes the cost of administrative supplies, equipment and vehicle usage; and

**WHEREAS,** said fee shall be for one year, and subject to future adjustments agreed to between the parties.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Hampton, Hunterdon County, New Jersey, as follows:

The Mayor and Clerk are hereby authorized to execute the attached Shared Services Agreement for the disposal of leaves between the Borough of Hampton and the Borough of High Bridge.
