## BOROUGH OF HAMPTON BOROUGH COUNCIL MEETING MINUTES

REGULAR MEETING December 9, 2019

Mayor Cregar called the Regular Meeting of the Hampton Borough Council to order at 7:30 p.m. The Open Public Meetings Act Statement was read by the Deputy Municipal Clerk. The notice of this meeting was advertised in the Hunterdon Democrat on January 10, 2019. The annual notice has been posted on the public bulletin board and has been filed in the Office of the Municipal Clerk.

The minutes of the Regular Session meeting of November 18, 2019 and the Executive Session Minutes of November 18, 2019 were approved as presented by the Deputy Municipal Clerk by a motion that was made by Cm Wotanowski second by Cm. Regar; Voice Vote: All ayes motion carried.

#### **Comments and Questions from the Public:**

State Troop was in attendance to see if any of the members of the Borough Council had any questions or concerns regarding the State Police coverage. There were none.

Rick Allen noted that everything is going along great with the Fire Company. Mr. Allen inquired if the members of the Borough Council had any questions or concerns regarding the Fire Company. There were none.

### **Communications:**

Letter from Boy Scout William Fleck regarding possible Eagle Scout Project. - Mr. Fleck will be in attendance. Mr. Fleck explained that he is a Boy Scout with Troop 1969 out of Stanton in Whitehouse Station, NJ and that he was here this evening to present his Boy Scout Eagle Project idea to the Borough Council. He explained that his two grandfathers were in WWII and his uncle was in Vietnam and that is what inspired him for this project. Mr. Fleck is proposing to place flags that represent the branches of the military at the memorial park here in Hampton. Mr. Fleck has spoken to Fire Chief Rick Allen. Mr. Fleck will meeting with Mr. Allen to see what the best design would work the best. Mr. Wotanowski recommended that Mr. Fleck work on the plan and come back to the Borough Council in January with the optimal design. The Borough Council is willing to consider this project.

**Letter from State of New Jersey Department of Transportation** advising the Borough that it will receive \$125,000.00 from the NJDOT Fiscal Year 2020 Municipal Aid Program for the Main Street Improvement Project- Phase 3.

#### **Old Business:**

Livestock Ordinance – Mrs. Leidner noted that the sample Ordinance is in the packets and reminded the Council Members that it can't be introduced until January. This was Tabled to the January 6, 2020 Regular Meeting.

**Court Shared Services** – Mr. Baker noted that he has visited the Clinton Township Court and has a tour of the facilities. Mr. Baker explained that the Borough will get all of the fine money back. Reports are much more detailed. Mr. Baker explained that there are more options for ways to pay fines. The signing of this contract will be Tabled to January 6.

A letter needs to be sent to Raritan Township letting them know that the Borough will be changing Courts. Mr. Baker advised Deputy Clerk Leidner to reach out to Borough Attorney Tara St. Angelo for a sample letter.

#### **Reports of Committees:**

**Cm. Swenson** – Mr. Swenson deferred to Alan Brower who reported that the generator for Well #5 will be coming tomorrow. Mr. B rower also reported that 80% of the wiring is done on Well #5, nothing on Well #4 yet. Once generator is set then the power can be attached. Panels came in but breakers were not there so Mr. Brower anticipates that in about a week or two the power in well house #5 will be on its own. Then he will work with the DEP to start up Well #5 so that work on Well #4 can begin.

**Cm.** Rega – Mr. Rega reported that we are in the investigation and assessment stage of the crossing guard process. Chief Kubinak has been around. The Borough.

Cm. Wotanowski had nothing to report.

**Cm. Baker** reported that he is still trying to speak with someone from Hampton School to get information as to how many kids graduated from there in the last 4 years and how the school spent their budget last year.

**Cm. Tampier**- Mr. Brower reported that almost all of the Christmas lights are up. Mr. Brower noted that they rented a lift but recommended purchasing a new or used lift. Because it can be used for many things throughout the Borough.

**Cm. Drummond** explained that the garbage truck suffered a catastrophic failure the engine dropped a lifter and wiped out the cam and sent metal fragments throughout the engine. The engine needs to be replaced, the work began today. Mr. Drummond anticipates the truck to be back the middle of next week. In the meantime we will be sharing Glen Gardner's garbage truck so garbage will be collected on Tuesday and recycling on Wednesday.

### **New Business:**

### Discussion - Rates for Park Rentals, Water Connections and Dumpsters for 2020

**Park Rentals** – Mr. Brower explained that the cost to get rid of garbage has gone up and the cost to have the bathrooms cleaned adds up especially when there are back to back rentals. When there are back to back rentals someone has to come in and prepare the park for the next rental and that costs the town overtime fees. The fees have not been raised in a long time. After a discussion the following rate change will go into effect after the Resolution is passed in January:

Hampton HRA, HAS, HBCEF, Woman's Club – FREE (specific to organization, not individual members of) Refundable Security Deposit of \$300.00 remains the same.

**Dumpster Rentals** – Due to the rising cost of getting rid of garbage the cost of dumpster rentals should be increased. The new Dumpster Rental Rate will be \$225.00 upon passing the new resolution in January.

Water Connection rate must be set and put back into the Borough Code. This will be Tabled to 2020.
