#### **BOROUGH OF HAMPTON**

REGULAR MEETING JANUARY 6, 2020

Mayor Shaner called the Regular Meeting of the Hampton Borough Council to order at 7:50p.m. Mayor. Shaner gave the Open Public Meetings Act Statement. # **Comments and Questions from the Public:**

Rick Allen, Fire Chief reported that in 2019 the Fire Company had 146 calls:

50 Smoke/Carbon Monoxide Alarms, 37 Fires, 23 Motor Vehicle Accidents, 15 Natural Gas Odor, 6 EMS Assists, 5 Public Assistance Calls, 4 Landing Zones, 4 Tender Task Force, 2 Motorcycle Accidents. 20 Drills-14 Work Details, Multiple Fundraisers & Community Service Programs. Chief Allen also noted that there currently 40 members of which 29 are very active.

The members of the Borough Council thanked Chief Allen and all of the members of the Fire Company for their time and commitment.

**Former Mayor Jim Cregar** noted that he is confident that things are left in good hands. Mr. Cregar wished the Borough Council a successful new year. Newly Elected Mayor Shaner thanked Mr. Cregar for his kind words.

Newly Retired Borough Clerk Cathy Drummond congratulated the Borough Council members.

# **Communications:**

**Email request from William Flec**k to present and discuss proposed Eagle Project. Mr. Fleck will be in attendance.

Mr. Fleck distributed a packet that contained sample designs for the placement of the proposed flags that represent each branch of the military.

Mr. Allen recommends that the entire Borough Council physically looks at the site to be sure that everyone knows what this actually entails including maintenance, flag sizes and shadows due to the working sundial on the site.

Cm. Wotanowski offered to work with Mr. Fleck to help iron out the details and get the project o the point where a final decision can be made as to the feasibility of the project.

Cm. Drummond recommended that DPW Director Alan Brower be kept informed as well. Cm. Drummond also reminded them that mark outs will be needed prior to digging.
