Unfinished Business:

Fire Company request for Catering Company to use the kitchen:

Fire Company President Rob Walton explained that he reviewed the Draft Revised Lease Agreement and it had items in there that definitely did not apply to what is trying to be accomplished with the agreement. Borough Attorney Lyons agreed and noted that the agreement was received from the insurance company and is a standard agreement that needs to be modified to fit the needs of Hampton Borough, the Fire Company and caterer. Borough Attorney Lyons asked Mr. Walton to send his comments and concerns to the Borough Clerk and he will work on modifying the agreement.

Parking Ordinance – Mr. Brower indicated that his will be ready for introduction in January.

Lumberyard – Nothing new to report.

School Study/Hampton School Updates – Cm. Celentano reported that the school is continuing to work on the school study grant process. Cm. Celentano also noted that there is going to be a Holiday Tree Lighting held at the school on Sunday, December 12 at 6:00pm.

Mr. Brower explained that they reached out to the DPW to help with putting the lights on the tree. There is an issue with using the bucket truck due to the location of the septic field. Mr. Brower noted that a lift could be rented by the school. The DPW will help with the lights.

Mayor Shaner noted that businesses in town have donated towards the lights. Mayor Shaner also mentioned that he was asked if the members of the Borough Council would be willing to donate towards the lights.

Reports of Committees:

Cm. Drummond and Cm. Rega were absent.

Cm. Celentano, Cm. Rega, Cm. Tampier and Cm. Wotanowski had nothing to report.

DPW Director Alan Brower reported that the snowflakes will be installed as soon as the bucket truck is available to borrow from High Bridge.

Municipal Clerk's Report –

Mrs. Leidner reviewed certain Resolutions with the Borough Council Members that contain fees that will require a vote in the New Year. This was done to determine if the Borough Council would like to change any fees or leave them as they are currently.

Mrs. Leidner requested guidance on the request that was received from a resident to change minutes to reflect exactly what was said by them and the Borough Engineer during the "Comments and Questions from the Public" portion of 2 meetings.

Mrs. Leidner explained that historically minutes have been action taken and not verbatim.

The Borough Attorney and Hampton Borough Council Members had seen a copy of this request and agreed that the minutes should remain as written as no action was taken as a result of the discussions.

New Business:

RESOLUTION NO. 69-2021

New Jersey State League of Municipalities Conference Resolution No. 2021-17

**Resolution Urging the New Jersey Legislature to Create Legislation that Would Establish
Emergency Medical Services as Essential Government Services**

WHEREAS, the State designates police, fire, and sanitation as essential government services, affording residents and visitors the right to a timely response by law enforcement, who will address an issue relating to public safety and respond; as well as the right to receive fire prevention and suppression services; and the right to a clean community through sanitation services; and

WHEREAS, despite being an integral part of public health and safety, providing education, lifesaving skills, and transportation, when needed, Emergency Medical Services (EMS) is not an essential government service in the State of New Jersey; and,

WHEREAS, due to this oversight, municipalities are not legally mandated to afford their citizens and visitors with a licensed ambulance with certified Emergency Medical Technicians when a medical emergency arises; and

This Meeting was held in Person following all Covid Guidelines.

WHEREAS, a review of call volume reports in major municipalities reveals that individuals who live, work and play in New Jersey are significantly more likely to need Emergency Medical Services than Fire Department services due to the rapidly increasing EMS call volumes that have exceeded pace with the fire service in recent years; and

WHEREAS, while fire and police agencies receive new fire trucks and patrol cars as well as up-to-date equipment, EMS agencies struggle with funding, dated equipment, and unmet demand for personal protective equipment for their employees; and

WHEREAS, these issues have been exacerbated by the escalating levels of infectious disease entering the country; as the State has seen with SARS, Ebola, and, most recently the Coronavirus pandemic, EMS agencies have been forced to adapt to changing circumstances despite being shorthanded; and

WHEREAS, when staffing has fallen short, many municipalities have been left scrambling to afford some level of emergency medical service for its citizens; and

WHEREAS, a legislative finding that EMS is an essential government service, coupled with the same statutory scheme found for both fire departments under N.J.S.A. 40A:14-7 et. seq. and law enforcement agencies under N.J.S.A. 40A:14-106 et.seq., will correct the present inequities between public safety agencies and otherwise ensure that those who live, work, and play in New Jersey receive equal access to emergency medical care.

NOW, THEREFORE, BE IT RESOLVED, the League of Municipalities, in conference assembled, urges Governor Murphy and the Legislature to seek to create legislation that would provide funding for, and establish Emergency Medical Services as Essential Government Services; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded to the members of the New Jersey General Assembly and the State Senate, the New Jersey Commissioner of Health, the Lieutenant Governor and the Governor of the State of New Jersey.

**AUTHORIZING THE SALE OF BOROUGH OWNED PROPERTY AT
12 MacKENZIE ROAD, BLOCK 17, LOT 9, TO MATARAZZO PROPERTIES, LLC**

WHEREAS, the Borough of Hampton is the record owner of the property at 12 MacKenzie Road, Block 17, Lot 9 (the "Property") on the Tax Map of the Borough of Hampton; and

WHEREAS, N.J.S.A. 40A:12-13(a) authorizes a municipality to enter into an open public sale at auction to the highest bidder for property that is not needed for public use; and

WHEREAS, the Borough has determined that the Property at 12 MacKenzie Road, Block 17, Lot 9, is not needed for public use and that the Property should be sold by open public sale at auction to the highest bidders; and

WHEREAS, on July 12, 2021 pursuant to N.J.S.A. 40A:12-13(a), and Ordinance 01-2021, Hampton Borough Council authorized the public auction for the sale of the Property by public sale to the highest bidder; and

WHEREAS, notice of sale was duly published as required by law; and

WHEREAS, pursuant to said Ordinance, such public sale was held at the Borough of Hampton on August 3, 2021, at 11 a.m., resulting in no bids; and

WHEREAS, on September 13, 2021, pursuant to N.J.S.A. 40A:12-13(a), and Ordinance 10-2021, Hampton Borough Council authorized the second public auction for the sale of the Property by public sale to the highest bidder; and

WHEREAS, notice of sale was duly published as required by law; and

WHEREAS, pursuant to said Ordinance, such public sale was held at the Borough of Hampton on October 11, 2021, at 6:45pm, resulting in no bids; and

WHEREAS, now proceeding directly pursuant to N.J.S.A. 40A:12-13(a), Matarazzo Properties LLC, PO Box 419, Hampton, NJ 08827, has offered \$30,001.00 to purchase the Property

NOW, THEREFORE, BE IT RESOLVED, that the sale of Borough owned property located at 12 MacKenzie Road, Block 17, Lot 9, to Matarazzo Properties LLC, for the amount of \$30,001.00 is authorized by the Mayor and Council of the Borough of Hampton; and
