Mrs. Leidner also noted that the Tax Collector has requested to change her hours from Thursday 4:30-6:30pm to Thursday from 10am to noon beginning in March. All members of the Borough Council were in agreement that this change in hours request is fine.

Municipal Clerk Leidner reported that the newsletters have been mailed. She wanted to make the members of council aware that a letter was included regarding the shut off/interest on past due accounts moratorium that the Governor has extended to March 15. By law all utility account holders had to receive this letter whether their account was in arrears or not.

Mrs. Leidner also reported that the Borough Attorney has reached out to her regarding a lot line adjustment needed for Borough owned property 12 MacKenzie Road. DPW Director Alan Brower provided the details to the council.

Municipal Clerk Leidner explained that this year the Municipal Clerk's Conference will be held in person from March 21 through March 24, and she requested that the March 21 council meeting be canceled.
